

## WA Real Estate Agent Licence

As a Registered Training Organisation, the NSW Real Estate Training College is offering the WA Real Estate Agents Licence at a cost of only **\$2,995** or **\$2,400** if you hold a WA Sales Representative Certificate.

Successful completion of the WA Real Estate Agent Licence course, CPP50307 Diploma of Property Services (Agency Management), will give you the necessary educational requirements needed for application to the Department of Commerce and will enable you to be employed as a Licensee, a commission based salesperson or own and operate your own real estate agency.

Under the Act applicants are required to have at least two years continuous full-time experience in the real estate industry immediately preceding their application.

### Fast track your licence

If you have been working in the industry or have business exposure, you may be eligible for recognition of prior learning or credit transfer, ensuring a fast and cost effective licensing program. For further information, review our RPL application found in the main menu of our website.
