### Recognition Of Prior Learning

Recognition of Prior Learning (RPL) is the formal recognition that your current knowledge and skills meet the requirements of a given unit of competency, for example CPPDSM4003A Appraise Property. It does not matter how you achieved your current level of knowledge and competence – formal training, on-the-job training, self study, work experience, life experience.

What does matter is that you are able to provide evidence that your knowledge and competence meet the requirements of a particular unit of competency (competency standard). When you have provided this evidence and it has been accepted as proving your knowledge and skill in a particular area, you will be given credit for a specific competency without having to engage in further study.

Agents will normally have to complete modules in:-

- Trust accounting
- Property management or sales - depending on experience
- Auctioneering
- Business/finance

## What Fees Are Associated With RPL?

The NSW Real Estate Training College has a one off charge of \$145.00 to assess an RPL application. This fee is credited towards any training undertaken with our College. Please contact the College for payment.

## How Do I Apply?

- 1** Contact the NSW Real Estate Training College to talk with a qualified assessor who will outline the RPL process to you. This is a good time to ask any questions that you may have about the RPL process and to seek clarification where it may be needed.
- 2** Refer to information on qualifications required for each course including description of units. Refer to units of competency for which RPL is being sought - tick units
- 3** Produce an RPL evidence kit for each unit of competency for which RPL is being sought. Include evidence such as work experience, life experience and education/training academic transcripts. Please supply reason for seeking RPL for each module.
- 4** Complete and submit your application form with the supporting documentary evidence.

\* Please be aware the College may contact you to answer questions to support your application for RPL in specific units of competency.

## What Happens Next?

When you have provided all of your evidence, your application will be assessed and a decision will be made on whether you have achieved competence or require further training. When all the evidence has been assessed and a judgment reached, you will be notified in writing of the outcome.

## What Evidence is Required?

Please provide us with evidence of your experience! Simply fax, email or post to us copies of the following:-

- Current Certificate of Registration
- Letter of employment from your current employer or appropriate references
- Copies of the following documents:
  - Appraisal report - this can be a letter advising a vendor of your appraisal results
  - Listing report - this can be listing documentation completed by you
  - Selling report - this can be letters of offers made, letters advising of exchange and completion to settlement
  - Leasing documentation
  - Marketing examples - this can be copies of internet, print, letterbox drop marketing
  - Evidence of attending tribunals
  - Property maintenance plan
- Any academic transcripts you may have
